The Government is currently developing proposals for a 'Place Survey' which will replace the three-yearly Best Value Survey. It is proposed that the first such survey will be carried out in each local authority area in the country – probably starting in autumn this year.

The majority of questions will be mandatory but others can be added according to local preferences and priorities (for example, other questions that we will include will relate to satisfaction with the District Council, our visible services and the effectiveness of our communications).

County-wide discussions are underway in Essex between District and Borough Councils and Essex County Council to identify how best the surveys can be carried out across the County.

Braintree District Council will carry out a robust District-wide survey this year in order to:

- inform the budget setting process for 2009/2010
- assess views about the extent to which people feel we provide value for money
- assess satisfaction with a range of services.

If the negotiations with ECC are sufficiently advanced to meet the required timetable then we will participate in the county-wide approach but if they are not then we will move forward with our own survey this year and participate in the county-wide approach next year.

In addition to the annual survey, we will be adopting a corporate co-ordinated approach to surveys with more frequent 'service specific' customer surveys and more focussed local surveys will be introduced during 2008/09.
