



Introduction

This profile explores the demographic, social and economic characteristics of Halstead Trinity Ward and is largely based on data drawn from the 2011 Census. This profile is a snapshot, and is intended to support an understanding of Braintree District's Ward characteristics.

These ward profiles represent the new ward boundaries introduced in the Braintree District by the Electoral Commission from May 2015. This has meant that it has not been possible to directly source data from the 2011 Census for these new Wards, as they didn't exist when the Census was completed. Data for the rural Wards has been produced by adding up the Census data at a Parish level to make up the new Ward areas.

For the urban Wards, data has been used from Community Insight reports provided by Greenfields. This was necessary as the urban Wards are not made up of Parishes, meaning Census Parish data couldn't simply be added together to find the figures for these new areas. A comparison with the 2001 Census data has also not been possible for these urban areas.

About Halstead Trinity Ward

Halstead Trinity Ward is a predominantly urban Ward located in the centre of the Braintree District within the town of Halstead. The Ward roughly covers the eastern region of the town. Following the Ward boundary changes Halstead Trinity Ward has been increased in size (at the expense of Halstead St. Andrews Ward) to now include almost all areas in Halstead west of the River Colne, within its boundary.

Development Sites

The Braintree Development Plan sets out what, where, when, and how development will be managed in the District.

Whilst the National Planning Policy Framework July 2018 (NPPF) sets out the presumption in favour of sustainable development, planning law requires that applications for planning permission must be determined in accordance with the development plan unless material considerations indicate otherwise. The NPPF does not change the statutory status of the development plan as the starting point for decision making.

The current adopted Braintree District Development Plan is made up of a number of documents, including the Local Plan Review 2005 and the Core Strategy 2011.

The relevant maps show the allocations for homes, employment, open space and other designations. Inset maps can be found for each town or village with a defined development boundary, within which development is generally acceptable subject to the policies in the Plan. Areas outside of the development boundaries are classified as countryside where development is restricted to uses appropriate to the countryside.

The Pre Submission Site Allocations & Development Management Plan as amended by Further Changes (ADMP) was adopted at Full Council on 15th September 2014, as a material consideration in accordance with the Interim Planning Policy Statement. The ADMP also includes a Proposals Map and Inset Maps. The non-strategic sites and policies which are contained in the Pre Submission ADMP will be carried over into the new Local Plan unless new evidence or further changes in government policy require changes to be made.

The Authority begun work on a new Local Plan in the summer of 2014 to cover the period up to 2033. The new Local Plan is made up of two sections. Section 1 of the Plan is a Strategic Plan for North Essex - including the Garden Communities (This document is shared with Colchester Borough Council and Tendring District Council). Section 2 of the Plan covers policies, maps, sites for development, housing, employment, regeneration etc. within Braintree District.

Both sections of the Plan were submitted to the Planning Inspectorate in October 2017, with examination hearings opening on 16th January 2018 for Section 1 of the Plan. The examination of Section 2 of the Plan will take place once the examination on Section 2 of the Plan has been concluded. Latest information on the new Local Plan can be found using the link below:







Level of unpaid care provided



There was no Census 2011 life expectancy data available at a County level so the East of England region has been used instead as a comparison in the below table and chart.



The proportion of residents in the Ward who hold no qualifications is much higher than the proportions of residents who hold this as their highest level of qualification at a District or County level. There is also a much lower proportion of residents within the Ward that hold a level 4 qualification or above, compared to the proportion of residents overall in the District and Essex.





The proportion of "Married households" in the Ward is lower than the level overall seen in the District or County as a whole. The proportion of households in the Ward who are "Lone parent families" is higher than what is seen at an overall County or District level.



There are a lower proportion of residents who are "owner occupiers" or "privately rent" in Halstead Trinity Ward than at a District or County level. Residents are much more likely to be in socially rented accommodation than on average in the other comparable areas.

Household size

There was no information available in the Greenfields Community Insight reports on the household size of households in the urban Wards; instead Census 2011 data for the whole of Halstead has been used in the below chart and table.


Social housing stock




