
# Notice under Regulation 7 of The Neighbourhood Planning (General) Regulations 2012 (As amended)

## 1. Purpose of the Report

1.1 To provide Braintree District Councils (the Council) response to the Neighbourhood Area Application received from Shalford Parish Council.

#### 2. Recommendations

2.1 To approve the Neighbourhood Area Application for Shalford Parish Council.

#### 3. Summary of Issues

- 3.1 Shalford Parish Council have applied for the designation of a Neighbourhood Area. This is the first step in producing a Neighbourhood Plan. The applicant is Shalford Parish Council and the neighbourhood area which they are applying for is coterminous with the administrative boundary of the parish. As such the area application must be approved under Regulation 5A of the Neighbourhood Planning (General) Regulations 2012 (As amended).
- 3.2 The recommendations set out in this report will help the Council to deliver the following Corporate Objectives:
  - A well connected and growing district with high quality homes and infrastructure.

#### 4. Consultation

- 4.1 As this application is by a Parish Council and is for that Parish Council's area no general consultation is required.
- 4.2 On 10<sup>th</sup> February 2020 Cabinet approved the delegation of the approval for the designation of a Neighbourhood Plan Area to the Corporate Director. In taking this decision is required to consult with the relevant Cabinet Member for planning. The Cabinet Member for Planning and Infrastructure has been consulted prior to the taking of this decision and has confirmed that they have no objection to Shalford Parish Council seeking to designate the parish

as a Neighbourhood Area and that the matter should proceed through the Neighbourhood Plan process.

4.3 In addition any local ward Members should have the opportunity to comment prior to this decision being made. The Council has consulted both ward members, who confirmed their agreement to the application.

#### 5. Options

5.1 Option 1 – To approve the neighbourhood area application for Shalford.

No other reasonable options are available as per Regulation 5A of the 2012 Regulations.

## 6. Next Steps

6.1 The parish council will be notified of the decision and a Regulation 7 notice will be published on the Council website and on any local notice boards within the parish.

#### 7. Financial Implications

7.1 None currently. The Local Authority will be able to claim grant once the decision to send the Neighbourhood Plan to referendum is made.

<u>Shalford Parish Council – Application to designate a Neighbourhood Plan Area</u>

Under the Neighbourhood Planning Regulations 2012 (part 2, section 6) please accept this letter and the accompanying map as the Parish Council's formal application to designate a Neighbourhood Plan Area.

Turning to the regulations and in particular Part 2, regulation 5, we:

- 1. Include a map which identified the area to which the area application applies the Partish of Shalford as outline by the bold black outline.
- 2. The area is considered appropriate to be designated as neighbourhood area because:-
  - It is co-terminus with existing local government administrative boundaries
  - It is inclusive and will enable the designated neighbourhood to reach all potential areas of development
