### Statement of Common Ground

#### Between Mid Essex Clinical Commissioning Group (MECCG), NHS England (NHSE) and Braintree District Council

1. This Statement of Common Ground has been prepared to identify the areas of agreement between the Mid Essex Clinical Commissioning Group (MECCG), NHS England (NHSE), and Braintree District Council as the Local Planning Authority (LPA) on matters relating to the LPA's Section 1 Local Plan and the representations submitted by MECCG and NHSE concerning that document.

#### 2. General Matters

The LPA's have worked with the health sector, including the MECCG and NHSE, on a range of planning and development issues, including in particular a reliance on health sector input to the Councils' Infrastructure Delivery Plans' health and social care chapters. As recognised stakeholders, they have been formally consulted at every stage of consultation.

The MECCG (on behalf of and representing commissioned providers) and NHSE submitted representations to Section 1 of the Local Plan during the Publication Draft Local Plan consultation period ending 28<sup>th</sup> July 2017.
